City Council Approves New Ordinance for Developer-Funded Parks and Trails

At its October 22 meeting, the Addison City Council approved an ordinance introducing new guidelines for developer-funded recreational areas, including parks and trails. The ordinance addresses the growing need for open spaces as the town continues to experience residential and commercial development.

Developed with input from the Council, town staff, and a Public Advisory Committee, this policy ensures that Addison can maintain its high standard of parks and trails while accommodating future growth. The ordinance, initially discussed during work sessions on

June 25 and August 13, updates parkland dedication requirements, introduces a fee-in-lieu option for land dedication, and establishes a park development fee.

Key Components of the Ordinance:

- Parkland Dedication Requirements: Developers of residential projects that increase dwelling units must dedicate 1 acre of parkland for every 100 new units. The land must meet specific criteria, such as being near existing open space or aligning with the Town's Parks, Recreation, and Open Spaces (PROS) Plan.
- Fee-in-Lieu of Land Dedication: When land dedication is not feasible, developers may pay a fee of \$5,360 per dwelling unit, with a 30% discount. These funds will be used for acquiring land for parks and trails and will be managed in a dedicated fund.
- Park Development Fees: Both residential and commercial developments that increase dwelling units or commercial space will be subject to park development fees. Residential developments will pay \$2,549 per dwelling unit (with a 30% discount), while commercial fees will range from \$0.58 to \$1.34 per square foot. The collected fees will support the development of parks and open spaces.

The ordinance also provides developers the opportunity to earn credit for private park development and to make public park improvements in place of paying park development fees.

Long-Term Planning for Parks and Trails

This ordinance is based on recommendations from the Town's PROS Plan, which identified the need for updated land and funding strategies to meet Addison's long-term parks and recreation goals. The process began in April 2023 when Addison engaged consultant 110% Inc. to analyze parkland dedication requirements and development fees.

City Council Approves Ordinance Prohibiting Aggressive Dog Training on Town Property

At its October 22 meeting, the Addison City Council approved an ordinance amending Chapter 54 of the Town's Municipal Code to prohibit aggressive dog training on all Townowned property. The ordinance is part of an ongoing effort to enhance public safety and welfare, following a recent incident that highlighted gaps in the current regulations.

The ordinance defines aggressive dog training as "training for any form of protection including personal or area protection by the apprehension or warding off an individual or other animal by means of barking, threatening gestures, biting, or restraining by use of teeth." The new law prohibits this type of training on all Town property, including parks, streets, sidewalks, and even Addison Airport property.

This change was first discussed at a City Council work session on September 24, 2024, where staff presented the need to address potential risks posed by such training in public spaces. The ordinance provides an exemption for certified peace officers who may need to conduct this type of training as part of their official duties. Otherwise, any person who engages in aggressive dog training on Town property will be in violation of the law and could face penalties.

Volunteers Needed for Addison Airport Master Plan Steering Committee

Addison Airport is beginning the process of updating its Airport Master Plan (AMP) and is seeking community volunteers to serve on the Project Steering Committee (PSC). The AMP is a critical planning tool required by the Federal Aviation Administration (FAA) to ensure that airports receiving federal funding remain up-to-date in their development and operations. The last AMP update for Addison Airport was completed in 2016, and rapid growth since then has

made a new update essential.

A key component of this process is public involvement, and the PSC will play a vital role in representing community interests. The PSC will be composed of airport and community stakeholders, including Addison residents and business representatives. The committee will provide valuable input and ensure that the updated AMP reflects the needs and concerns of the local community.

The Town is inviting residents and business owners who are passionate about the future of Addison Airport to apply for one of these important volunteer positions. The application will be available on the Town's website through November 15 and the Council will make appointments at the December 10 City Council meeting.

Council Approves Agreement for Land Purchase for New Emergency Communications Center



At its recent meeting, the Addison City Council approved a resolution authorizing an Interlocal Cooperation Agreement (ILA) with Metrocrest Hospital Authority and the cities of Farmers Branch, Coppell, and Carrollton for the purchase of property to construct a new North Texas Emergency Communications Center (NTECC) facility. The NTECC, which provides vital public safety communications services, is approaching the end of its 15-year lease, prompting the need for a long-term solution to meet future operational needs.

The ILA marks a significant step toward building a dedicated facility for NTECC, which has been operating in leased space since its inception in 2014. An analysis conducted by NTECC's Executive Director revealed that constructing a new facility would save an estimated \$24.8 million over 30 years compared to continuing the lease. After considering these findings, the NTECC Board of Directors, comprised of the city managers from Addison, Farmers Branch, Coppell, and Carrollton, voted in favor of building a new center.

The selected site for the new NTECC facility is an undeveloped parcel of land owned by the Metrocrest Hospital Authority, located near Medical Parkway and Hebron Parkway. The total cost of the land, including closing fees, is \$3.2 million. Addison's share which is based on the Town's average percentage of calls for service, is 16.807% or \$537,824. To fund this project and the future construction costs, the Addison City Council has approved the issuance of \$3.4 million in Certificates of Obligation.

All four of the cities have approved the ILA so the next step is for the NTECC Board to approve the final construction cost by April 2025. Construction is expected to begin in October 2025, and the new facility will start providing public safety communications services

by October 2028.

City Council to Move Ahead with Next Steps for Tollway Pedestrian Crossing Plan





At the October 22 City Council meeting, staff presented the latest progress on the North Texas Tollway Authority (NTTA) Pedestrian Crossing Feasibility Study at Belt Line Road. This study represents a key step in improving pedestrian and bicycle access across the Dallas North Tollway (DNT), addressing one of the most significant barriers to safe and convenient active transportation between west and east Addison.

The feasibility study stems from the City-Wide Trails Master Plan (CWTMP), adopted by the Council in May 2021, which highlights the Dallas North Tollway (DNT) as the greatest obstacle for active transportation between west and east Addison. Specifically, Chapter 5 of the CWTMP emphasizes the need for a safer crossing at the Belt Line Road overpass, where a shared-use path for pedestrians and cyclists could dramatically improve access across the tollway.

In the FY2023/2024 budget, funding was set aside to examine potential solutions. Engineering firm Kimley-Horn Associates was brought on board to conduct a feasibility study to determine the best approach for creating a pedestrian and bicycle crossing along Belt Line Road. Their work includes structural and roadway analysis, preliminary and final conceptual design, and 3D renderings to help visualize the crossing.

A key feature of the study was the closure of the southside bridge U-turn at Belt Line Road, which allowed traffic engineers to observe pedestrian and vehicle activity during peak hours.

The data gathered will guide recommendations on future signal adjustments and ensure traffic safety.

Beyond enhancing pedestrian and cyclist safety, another goal was to create a recognizable landmark that will identify the town to drivers along the Dallas North Tollway. The next phase will involve coordinating with the City of Dallas, including the use of Dallas right-of-way, to move the project closer to fruition and explore funding mechanisms.
